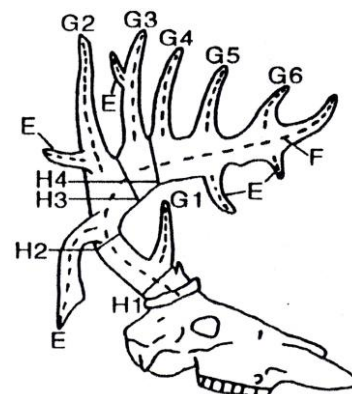

Fair Chase Affidavit

The term "fair chase" shall not be held to include the taking of animals under the following conditions:

- 1. Helpless in, or because of deep snow, helpless on ice, helpless in a trap, or while swimming.
2. Confined behind high fences as on game farms etc.
3. In defiance of game laws and regulations
4. By "jacklighting" or "shining" at night.
5. From any motorized vehicle.
6. By the use of any power vehicle for herding or driving any animals, including the use of aircraft for landing alongside of any animal or herd, or to communicate with or direct a hunter on the ground.
7. By the use of an tranquilizers or poisons.
8. Any other method considered by the board as unsportsmanlike.

Any falsification of this affidavit will cause this entry to be rejected, no future entries accepted, and all past entries dropped from the record book.
